# Chair's Introductory Comments and Updates - Chair Troy Costales

## Update on Nursing and Psychology Compacts

Jim Puente, Director of the Nurse Licensure Compact (NLC), and Janet Orwig, Executive Director of the Psychology Compact (PsyPact), provided updates on the status of their respective compacts.

## Review of 2018

T.J. Cantwell, Compact Administrator, presented highlights of activities and accomplishments during 2018.

## Projections and Strategy for 2019

T.J. Cantwell, Compact Administrator, provided an update on when existing PT Compact member states are projected to be ready to begin issuing and accepting compact privileges. He also talked about states that are interested in potentially introducing compact legislation in 2019.

## Review and Adopt Rule Amendments

All public comments received regarding the proposed rule amendments were provided to Delegates prior to the meeting and reviewed by the Commission Delegates during the meeting. No comments or requests were made for a formal hearing therefore the Commission was permitted to make a final decision without a formal hearing.

After discussion of the comment received from the Iowa Board of Physical Therapy regarding the proposed amendment to add paragraph B to Rule 3.7, it was determined that further discussion was needed on the specific amendment.

<u>Motion</u>: Kentucky moved that the Physical Therapy Compact Commission remove the amendment of paragraph B to Rule 3.7 and refer it back to the Rules and Bylaws Committee for further review. Colorado seconded the motion. All present voted yes. The motion carried.

There were no additional comments on the proposed Rules for Delegates.

<u>Motion</u>: New Jersey moved that the Physical Therapy Compact Commission adopt the proposed Rules amendments as modified. Kentucky seconded the motion. All present voted yes. The motion carried.

#### **Review and Adopt Bylaws Amendments**

The Commission reviewed the proposed Bylaws amendments. There were no comments.

<u>Motion</u>: New Hampshire moved that the Physical Therapy Compact Commission adopt the proposed Bylaws amendments as submitted. Utah seconded the motion. All present voted yes. The motion carried.

<u>Review and Adopt Policies and Procedures</u> The Commission reviewed the proposed policies and procedures. There were no comments.

<u>Motion</u>: Colorado moved that the Physical Therapy Compact Commission adopt the proposed policies and procedures as submitted. Kentucky seconded the motion. All present voted yes. The motion carried.

## **Elections**

Per Bylaws, three positions on the PTCC Executive Board were open for election; Vice Chair, and 2 Member-At-Large seats.

The slate of candidates for the open positions were presented. Kathy Arney was the sole nominee for Vice Chair. Harvey Aikman, Scott Majors, and Joe Shanley were the nominees for the two Member-At-Large seats.

No additional candidates were nominated from the floor.

Since the position of Vice Chair was unopposed, the election was conducted by voice vote.

<u>Motion</u>: Kentucky moved to elect Kathy Arney as Vice Chair by acclamation. South Carolina seconded the motion. All present voted yes. The motion carried.

Based on the ballot votes cast, Harvey Aikman and Scott Majors were elected as the Member-At-Large Delegates.

#### **Review and Adopt Budget**

Secretary/Treasurer DeKrey provided an overview of the proposed 2019 annual budget.

<u>Motion</u>: Colorado moved that the Physical Therapy Compact Commission adopt the proposed 2019 budget as submitted. New Jersey seconded the motion. All present voted yes except for Arizona. The motion carried 18 to 1.

# Alternative Mechanism for Louisiana SSN and DOB

The Commission reviewed and discussed the proposed alternative mechanism for Louisiana to comply with the Rule 6.1.

**Motion:** Texas moved that the Physical Therapy Compact Commission accept the alternative mechanism for Louisiana to comply with Rule 6.1 based on the understanding that the proposed remedy is deemed to be substantially equivalent with the rule, contingent upon the Louisiana Physical Therapy Board requesting an opinion from the Louisiana Attorney General's office that would allow the sharing of the licensee social security numbers and dates of birth with the Physical Therapy Compact Commission. The motion was seconded by Tennessee. All but Louisiana voted Yes. Louisiana abstained. The motion carried.
