# Call to Order

The meeting was called to Order at 3:03 PM, ET.

#### Approval of Minutes from January 9, 2018 Meeting

### Discussion of FBI Criminal Background Check Rule Interpretation

T.J. Cantwell explained that member states had different interpretations of the FBI criminal records check requirement under the statute and current rule. These points of view impact when a member state would be eligible for Compact Privileges. After discussion, the Executive Board requested that the Rules and Bylaws Committee review the issue and provide recommendations to the Executive Board for consideration as soon as possible.

<u>Motion</u>: Kathy Arney moved that the Executive Board go into closed session pursuant to Section 7.E.2.a of the Compact Statute to discuss matters related to the non-compliance of a member state with its obligation under the Compact.
