Call to Order

The meeting was called to Order at 12:03 PM, ET.

Approval of Minutes from September 19, 2018 Meeting

<u>Motion:</u> Kathy Arney moved to approve the September 19, 2018, Executive Board meeting minutes as submitted. Harvey Aikman seconded the motion. The motion carried without objection.

Discuss and Vote on Policies and Procedures

T.J. Cantwell and Joe Shanley reviewed the draft policies and procedures with the Executive Board with edits received after informal comment from Commission Delegates.

<u>Motion:</u> Harvey Aikman moved that the Executive Board approve the draft policies and procedures for review and adoption by the Physical Therapy Compact Commission at its October 28, 2018 annual meeting. Joe Shanley seconded the motion. The motion passed.

Discuss and Vote on Louisiana SSN and DOB Alternative

T.J. Cantwell provided a brief overview of the current issue concerning the Louisiana Physical Therapy Board's ability to share the social security numbers and dates of birth for licensees in its database. The Executive Board was provided a confidential background document detailing the issue and discussions with Louisiana. Staff proposed an alternative mechanism to comply with Rule 6.1.

<u>Motion:</u> Harvey Aikman moved that the Executive Board recommend that the Physical Therapy Compact Commission accept the alternative mechanism for Louisiana to comply with Rule 6.1 based on the understanding that the proposed remedy is deemed to be substantially equivalent with the rule, contingent upon the Louisiana Physical Therapy Board requesting an opinion from the Louisiana Attorney General's office that would allow the sharing of the licensee social security numbers and dates of birth with the Physical Therapy Compact Commission. Kathy Arney seconded the motion. The motion passed.
