

Check Eligibility

- Hold a valid PT or PTA license in your home state (must be a compact member).
- Have a valid driver's license proving permanent residency in your home state.
- · No active encumbrances or disciplinary actions in the past two years.
- . The state you want to practice in must be a compact member.



If I violate the physical therapy practice act, the appropriate physical therapy board may take action against my Compact Privilege, which will result in the immediate revocation of all other Compact Privileges I may hold. I will also be prohibited from obtaining any other Compact Privileges for a period of at least two (2) years.

I will also be prohibited from obtaining any other Compact Privileges for a period of at least two (2) years.
